The 10 Essential Public Health Services describe the public health activities that all communities should undertake:

- 1. Monitor health status to identify and solve community health problems
- 2. Diagnose and investigate health problems and health hazards in the community.
- 3. Inform, educate, and empower people about health issues.
- 4. Mobilize community partnerships and action to identify and solve health problems.
- 5. Develop policies and plans that support individual and community health efforts.
- 6. Enforce laws and regulations that protect health and ensure safety.
- 7. Link people to needed personal health services and assure the provision of health care when otherwise unavailable.
- 8. Assure competent public and personal health care workforce.
- 9. Evaluate effectiveness, accessibility, and quality of personal and population-based health services.
- 10. Research for new insights and innovative solutions to health problems.

Breastfeeding Peer Counselor Program

The breastfeeding peer counselors work with WIC Mothers who are planning on breastfeeding or are currently breastfeeding. The goal of the breastfeeding peer counselor programs is to increase the rate of breastfeeding mothers in Laurel County. They provide support and assistance for the mother in the case of breastfeeding complications.

Communicable Disease/Epidemiology

The Communicable Disease Program is responsible for the prevention and control of certain infectious diseases. Physicians, hospitals, and laboratories report communicable diseases as required by 902 KAR 2:020 to the Epidemiology unit of the health department. Qualified health department staff persons provide investigation of the cases and report the communicable diseases to the state office which reports to Centers for Disease Control and Prevention.

Diabetes Education Program

Services include Comprehensive diabetes self-management education classes, support groups, weight loss classes, and public awareness activities are also included in the program, available for workshops for civic clubs, seniors, and religious organizations on diabetes risks.

Grief Counseling Referrals

This service is available to any parent or family member who has experienced an infant/child loss (birth through 17 years of age) as the result of stillbirth, miscarriage, or infant/child death. The local health department can provide referrals for these families for grief counseling services.

HANDS Program

The HANDS home visitation program is a voluntary, intensive program designed to assist new or expectant parents at critical development points during the baby's first years of life. It targets women during their pregnancy to assist with development, parenting skills, health services and other needed resources.

Harm Reduction Program

The Harm Reduction Program provides services for individuals with Substance Use Disorder. At this time, these services include a Syringe Exchange Program including Peer Support Services and a Community Health Worker Program for pregnant women enrolled in a Neonatal Abstinence Syndrome program.

Health Education Programs

Provides health education programs for all age groups on a variety of health-related topics to the community, including groups, organizations, institutions, and public/private schools.

Home Visiting Services

Contacts: Any Public Health Nurse

This service is available through the local health department and all departments throughout Kentucky. It may be performed due to referrals from private physicians and/or hospitals. It is available to any Kentucky citizen. All home visits must meet 907 KAR 3:130 medical necessities.

Immunization Program

Contacts: Carolee Epperson, RN

The immunization program is available to children 18 years of age or younger to ensure that all children are adequately immunized for prevention of disease. Vaccines for adults such as flu and pneumonia are also available.

Lead Screening Program

Contacts: Carolee Epperson, RN

The program is available to children that may be exposed to situations where lead exposure exists. Routine screening with a risk assessment is performed. This service is offered during preventive health visits and is not intended to be done as an independent service.

Medical Nutrition Therapy Counseling Services

Brandi Gilley, MPH, RDN, LD

Provides nutrition counseling services on a one-on-one basis for cholesterol, hypertension, diabetes, food allergies, weight loss, or other nutrition-related diseases. This is a billable service. If you do not have insurance or your insurance is not accepted, the fee will be based on household income.

Preconception Health Care

This program utilizes assessment skills for the identification of conditions that could affect a future pregnancy but may be altered by early intervention with maternal lifestyle modification and improved health prior to conception.

Public Health Preparedness

The public health preparedness coordinator works with local and regional response partners for development of emergency operations plans. Local and regional exercises are developed, executed, and evaluated to demonstrate proficiency in responding to bioterrorism, infectious disease outbreaks, as well as weather-related emergencies and natural disasters.

Sexually Transmitted Infection and HIV Services

The program is conducted at each health department giving face-to-face pre-test and post-test counseling by a qualified counselor trained in the HIV counseling, testing and partner notification course.

TB Program

The program is intended for the education and prevention of TB.

Tobacco Dependence, Treatment and Counseling Prevention Services

The program is intended for the education of the public on the effects of tobacco abuse and prevention efforts geared toward youth cessation programs, adult cessation programs, and healthy home and work environments. WIC Program

The Special Supplemental Nutrition Program for women, infants, and children provides, without cost to the recipient, specific nutritious foods along with nutrition education to low income and nutritionally at risk pregnant, breastfeeding, and postpartum women and to infant and children up to the age of five. The goals are to improve the outcome of high-risk pregnancies, to decrease the incidence of anemia, poor growth patterns and to improve dietary habits of the recipients through healthy foods and nutrition education.
